### MSU ARC Meeting - May 2, 2023

Meeting was called to order by President, Tracy McKinney, W4IRT, at 7:00 p.m.

**Roll Call & Question of the Night**: Roll call was done and the question of the night was, "Have you made any long-time friends through HAM radio, may even friends that you may never meet in person?"

**<u>Program</u>**: Steven Dabbs, KN4IRN, presented a brief and informative program about HAM radio equipment and insurance.

- He went over the different types of equipment and accessories that you should consider insuring as they are a part of your radio investments, like: radios, power supplies, amps, computers, towers, antennas, coax, etc.
- Steven reviewed the various types of events that could cause damage or you to lose your equipment, like: fire, lightning, windstorms, hail, power surges, water damage, or theft.
- Steven explained the differences that you might find between using your home owner's insurance versus ARRL insurance to cover your radio equipment.
- He also explained your duties after a loss of equipment
  - Proof of ownership
    - Receipts
    - Damaged equipment
    - Photos
  - Proof of loss
    - Proof of damage by a "qualified" business
    - Evidence supporting the type of damage
    - Repair or Replace
    - Photos
- Steven explained how the value the equipment lost is assessed taking into account the following:
  - Replacement costs
  - Actual Cash Value (market value)
  - Appreciate/Depreciation

<u>Vice President's Report:</u> Diana Mishica, K4IRU, encouraged the club to make suggestions on future program topics and to volunteer to present if they would like to share.

<u>Secretary's Report:</u> Bill Call, KJ4W, moved that the April meeting minutes be accepted as submitted. Jana Hackathorn, KN4MWE, seconded the motion. Motion was carried.

<u>Advisor Report</u>: Jana Hackathorn, KN4MWE, advised that she has been able to retrieve our mail. Debbie Barton, W8IBT, sent a test mail on 03-01-2023 and we just received it two weeks ago. Jana reports that we received a bill from the MSU newspaper, the bill was past due but we just now received it. Jana will give it to Bill Call, KJ4W, to be paid.

QSL Manager Report: Debbie Barton, W8IBT, was not present to report anything.

<u>Treasurer's Report:</u> Bill Call, KJ4W, reported that debit card payments were made to W5YI-VEC for VE fees for \$28.00 and to Risk Strategies for the ARRL Club Liability Insurance for \$300.00. There was one deposit for \$245.00. Current bank balance is \$3,526.62. As of tonight's meeting, we have 82 paid members for 2023. At this point, only paid members may make or vote on motions at the meetings, or serve as an officer. A past member who has not paid their dues may catch up at any time during the year.

System's Report: Bill Call, KJ4W, reported that the 443.800 repeater including EchoLink and the 2m Winlink node were offline for a few days last week after a noise problem affected the repeater. He could not find the problem while at the repeater site in the penthouse of Faculty Hall, and in the process he apparently tripped a building circuit breaker which he never could find which shut down the power to penthouse receptacles. Bill took the repeater and its interface to the external controller home to test them. He was unable to find anything wrong with them and took them back to Faculty Hall last Friday. MSU still hadn't fixed the power problem so Bill used a long extension cord to a good outlet to get us going again, and everything worked fine then. He is guessing that no components had failed, but that the external controller had hung and just needed to be power-cycled. In the process of studying the repeater at home, he dug out our "spare" Yaesu repeater that used to be used on 146.940 and added the connections to it that he had added inside the 443.800 repeater 7 years ago to adapt it to EchoLink. So now the spare repeater would be quicker to swap into service on 443.800 if needed. Bill also cleaned a bunch of dust out of both repeaters—the Yaesu repeaters have a cooling fan that runs full-time and that brings in quite a bit of dust over the years. Also last week the MSU Network guys installed the new network feed cables in the club station and Bill restarted the HF Winlink gateway station, and all seems to be well with the computer network in the station. The 3 Club repeaters, the 2 APRS digipeaters and the two Winlink systems are all working well as far as Bill is aware.

<u>VE Report</u>: Bill Call, KJ4W, advised that an exam session was held after the April meeting. Four HAMs from the General Class License study course upgraded to General Class! Congratulations to Dr. Jordan Garcia, KN4AXN; Jerry Holt, N1BLH of Paris; Richard Holt, K4HNB of Paris; and Donna Pursifull, KQ4FEU. W5YI-VEC and the FCC have improved the turnaround time for upgrade processing, and the upgraded licenses were posted the next evening. A VE session will be held tonight after the meeting.

<u>CERT Report</u>: Bill Call, KJ4W, reported that Facebook page for CERT activities has been created and is waiting to be approved by Emergency Management Director, Jeff Steen. It is still in the start-up stage at this time, but if you are on the master list of contacts you should receive an invite when it is up.
