MSU ARC Meeting – June 6th, 2023

Meeting was called to order by President, Tracy McKinney, W4IRT, at 7:00 p.m.

Roll Call & Question of the Night: Roll call was done and the question of the night was "What is your favorite part of Field Day?"

<u>Program</u>: Josh Kerr, WV4O, presented a thorough and informative program about ARRL Field Day. He explained that it is always the 4th full weekend in June. Josh went over the purpose, basic rules, the contact exchange, scoring, station set-up, and strategies of Field Day. Josh explained how are club usually prepares and sets up for Field Day and shared pictures and stories of past Field Days. He gave hints for how to operate during Field Day since it is such a large event and encouraged everyone to sign up and participate. Josh reminded everyone to just have fun and enjoy the friendship and fellowship that comes along with HAM radio and Field Day. <u>Secretary's Report:</u> Bill Call, KJ4W, moved that the May meeting minutes be accepted as submitted. John Coyle, W4PJC, seconded the motion. Motion was carried.

<u>Advisor Report</u>: Jana Hackathorn, KN4MWE, reported that the club received one piece of junk mail and that was all.

QSL Manager Report: Debbie Barton, W8IBT, did not have anything to report.

<u>Treasurer's Report:</u> Bill Call, KJ4W, reported that a debit card payment was made to W5YI-VEC for VE fees for \$7.00. One check was written to The Murray State News for the ad from last Homecoming for \$40.00. There was one deposit for \$60.00. Current bank balance is \$3,539.62. Prior to the meeting we have 86 paid members for 2023.

System's Report: Bill Call, KJ4W, advised that EchoLink and the 2m Winlink node were offline yesterday which meant that the EchoLink hookup to the 94 repeater didn't work for the Monday night net. Bill restarted the computer this morning and it all works again. He doesn't think it was a power failure, but rather a forced restart by MSU for a security update. That repeater system is still running on the long extension cord to a good outlet. He also has had to restart the HF Winlink gateway station a couple of times after a computer shutdown. Bill thinks the problem there is with the battery backup system, and he has taken that back home to test. Bill reported that we borrowed the Broadband Dipole antenna from the HF Winlink station last Saturday for the KyQSO Party, and it and the IC-7300 station worked well. Also last month he had to repair 2 of the guy ropes on the 94 repeater antenna on Fine Arts building, again. He believes that birds have been attacking the ropes. Bill bought a new type of rope at Dayton Hamvention that he will try at some point. The 3 Club repeaters, the 2 APRS digipeaters and the two Winlink systems are all working OK at the moment as far as he is aware.
