MSU ARC Meeting – March 7th, 2023

Meeting was called to order by President, Tracy McKinney, W4IRT, at 7:00 p.m.

Roll Call & Question of the Night: Roll call was done and the question of the night was "Do you have your equipment set up to use WinLink and do you use it?"

<u>Program</u>: Bob Aldrich, WD8OWA, presented a very informative and entertaining program on the <u>Condensed History of Amateur Radio</u> (part 3).

- Bob provided interesting history of amateur radio from the end of World War II until "not too many years ago" Including:
 - The allocation for 6 meters (during the war)
 - Being allowed on 10 and 2 meters (November 1945)
 - Military leaving the HF bands and losing 160 meters to the LORAN navigation system, and the new tenth call district (1946)
 - Addition of 15 meters and expansion of some bands (1947)
 - Major restructure of license class and expansion of phone privileges (1951)
 - First SSB transmitter for HAMs (1953)
 - o First amateur moonbounce (1953) and first 2-way success (1960)
 - Morse code testing requirements dropped (2007)

<u>Vice President's Report:</u> Todd Hackathorn, W4GV, had nothing new to report but, as always, we encourage input regarding future presentations.

<u>Secretary's Report:</u> Bill Call, KJ4W, moved that the February minutes be accepted after a correction is made correcting the language in the following excerpt from the New Business section:

Bill's motion this evening was to amend our policy of waiving reimbursing the Application Fee and reducing the Exam Fee to \$5.00 for applicants under 18 years old to under 18 years old and/or an MSU student."

The motion was seconded by Jana Hackathorn, KN4MWE. Motion approved.

<u>Advisor Report</u>: Jana Hackathorn, KN4MWE, advised that she has found the mail and they are still working on getting the new system all sorted out and organized. She also stated that they informed her that the late Mike Lyons, KK4PDL, paid for 5 years of mail service prior to his passing but she will investigate that more.

QSL Manager Report: Debbie Barton, W8IBT, reports that she received one QSL card from AB1A from the June of 2022.

<u>Treasurer's Report:</u> Bill Call, KJ4W, reported that checks were written to W5YI-VEC for VE fees for \$14.00; to Tracy McKinney, W4IRT, to reimburse for purchase of the new IC-7300 for \$1083.95; and to Josh Kerr, WV4O, to reimburse for website fees for \$67.00. The debit card was used to purchase a replacement battery through eBay for the EchoLink / 2m Winlink computer in Faculty Hall for \$21.19. Bill advised that he finally calculated what was owed to himself for materials used in the HF Winlink station setup and did a Credit Union Transfer for that reimbursement of \$148.10. There was one deposit for \$159.00. Current bank balance is \$3,380.62. As of now, we have 62 paid members for 2023. This year's dues are due prior to the start of the next meeting, which is April 4, 2023.

System's Report: Bill Call, KJ4W, reported that he replaced the battery in the Faculty Hall computer UPS that is used for EchoLink and the 2m Winlink node, and restarted that computer after it had crashed. He reported that the guy ropes used to hold the 25 foot mast pipe steady that the 146.940 repeater antenna is mounted on, on the top of the Fine Arts building, were all broken, and he replaced those before the two recent wind storms. Bill used ropes from the Field Day supplies so we may need to get some replacement ropes. From what Bill can see we have had no damage from the storms. Bill state that he has worked some more on the trailer tower; the old network wiring and equipment have been removed. Bill believes we could sell the microwave equipment, if we don't want to work with it, for maybe a couple of hundred dollars. The 3 Club repeaters, the 2 APRS digipeaters and both of the Winlink systems are all working OK as far as he is aware.

<u>VE Report</u>: Bill Call, KJ4W, advised that an exam session was held after the February meeting. Michael Inman passed his Technician Class license exam and was issued KQ4GBG which he has now replaced with K4MWI. Dennis Pitman, KQ4FJB, of Fulton, who passed his Technician Class license in January, upgraded to General Class. A VE session will be held tonight after the meeting if needed. The General Class course on Thursday nights is nearly finished; we will meet one or maybe two more times.

<u>CERT Report</u>: Bill Call, KJ4W, reported that we had a good turnout at the Skywarn training in February. We postponed the siren testing which had been planned for last Friday because of the weather forecast. He hasn't heard if a decision has been made for testing this Friday. Jeff Steen is planning a special training session for CERT members on March 16, and we have about 40 signed up for that training!
